Editorial Freelancers Association



The <u>Editorial Freelancers Association</u>, sponsored by **Andy Huston '73**, is an organization that provides two Ruth Mullen Memorial Scholarships annually to an undergraduate attending an HBCU (historically Black college or university) and a HBCU alum attending graduate school who are pursuing careers in publishing or communications. African Americans are underrepresented in these important fields. EFA needs people with fundraising expertise and connections to help them continue these scholarships.

CommUnity Cares Health, Inc.



<u>CommUNITY Cares Health, Inc.</u>, sponsored by **Tom Schneider '73**, is a Cambridge/Boston based organization that envisions a future where health and well-being are central to the Black American experience. CommUNITY Cares focuses on bringing young Black people to gatherings such as music

festivals, where there is also direct access to preventive healthcare, good nutrition and education. By fusing medical education and access to healthcare with cultural resonance, they are a gateway to consistent high-quality healthcare. This small organization is hoping to expand into other states and needs guidance and consultations on strategic planning, communications, legal work, board development and fundraising.

Case History: How the ClassACT HR73 Bridge Program works

In a wonderful example of how the ClassACT HR73 Bridge Program works, The Cole Resource Center (CRC) announced that **Mary Lyons-Hunter**, **PysD**, has joined its Board of Directors. Lyons-Hunter is Unit Chief of the Behavioral Health Department at the MGH Chelsea Health Center and Instructor at Harvard Medical School. CRC leadership first "met" Mary through ClassACT HR73 in March 2023 when she spoke as a panelist at its online forum "Addressing Anxiety & Depression in Young Adults." Through conversations this fall, we discovered common interests and a shared commitment to supporting community mental health. Mary officially joined the CRC Board in November 2023.

ClassACT HR73 Launches a New Webinar Series for Bridges





Sylvester Monroe, Classmate and Journalist Two Steps Forward

This month's <u>@.50 Video Project</u> features **Sylvester Monroe**, one of the 139 Black students who arrived at Harvard in September 1969. In this powerful video, produced and edited by classmate **Rick Brotman**, you hear Vest's discussion of how he ended up at Harvard and his journey in his successful career as a Black journalist, always with an undercurrent of the "dull pain of cultural isolation." Vest covered stories about such major figures as Rodney King, OJ Simpson and Barack Obama for Newsweek, Time and Ebony, but there were also important stories that were never brought to light. He provides thoughts on how journalism as "the first draft of history" has omitted the Black perspective.

Update on Ukraine: Issues and Analysis

Thanks to all who attended our ClassACT HR73 Forum <u>Update on Ukraine</u>: <u>Issues and Analysis</u> on November 13, 2023.

Timothy Snyder, the esteemed historian of modern Eastern Europe and the Richard E Levin professor at Yale University, said at the end of last year:

"Americans (and many others) owe Ukrainians a huge debt of gratitude for their resistance to Russian aggression. For some mixture of reasons, we have difficulty acknowledging this. To do so, we have to find the words. Seven that might help are: security, freedom, democracy, courage, pluralism, perseverance, and generosity."

Moderator **Bill Kristol '73**, a widely respected analyst of global affairs and founding director of <u>Defending Democracy Together</u>, led a discussion on the current state of the war in Ukraine, the stakes for the international security system as well as for U.S. global leadership, and the urgent need for increased funds for weapons and training for Ukrainian troops. Joining him was an eminent panel that included Nobel Prize-winning economist

Roger Myerson '73; former U.S. Ambassador to Croatia

Peter Galbraith '73; and international security expert and retired Marine
Colonel Mark Cancian '73.

"This is the largest war in Europe in eighty years," said Bill Kristol. "There are tactical and strategic ups and downs. But in terms of the big picture, Putin invading a neighbor and attempting to conquer it and destroy its people as an autonomous people in Europe, on the border of six NATO countries, is a pretty astonishing thing to happen."

A consequence of Putin's victory would be the huge diminishment of U.S. leadership in a troubled world, Peter Galbraith said. "What is at stake is the entire international system since 1945," said Galbraith, pointing to the multilateral consensus that once a nation becomes a member of the United Nations, it does not have the right to invade another member's territory. "If Russia gets away with it, it opens the door to others."

In their calls to action the panelists urged the audience to contact members of Congress to ask them to support the recent request for additional assistance to Ukraine. Mark Cancian reminded his listeners that 60 percent of the U.S.'s money for Ukraine is spent in this country, particularly for the procurement of weapons. Finally, Roger Myerson asked for support for the KSE
Foundation at the Kiev School of Economics, which has been raising funds for

charitable assistance to Ukrainians since the start of the conflict.

At the forum's end, ClassACT HR73 Chair Marion Dry called upon the audience to donate to non-profits like <u>Save the Children</u> or the <u>International Rescue Committee</u>, which have been providing food and medical supplies to the Ukrainian people.



Pennsylvania Supreme Court Keeps Gerrymandering At Bay

In our recent articles, we have focused on voting rights issues in the battleground states that may be key to the outcome of the 2024 Presidential Election. We have covered developments, some of them adverse, in Georgia, Ohio, North Carolina, and Virginia. This month we turn to Pennsylvania, where the outlook for fair elections is more promising.

Courts have often played an important role in the protection of voting rights and fair elections. As a result, judicial elections have become significant contests in the struggle over voting rights. In the November 2022 elections, when Dan McCaffery won his race to become a Pennsylvania State Supreme Court Justice, the Court swung to a 5-2 Democratic majority. Had the Republican candidate won, the Democratic majority would have remained 4-3. Given the stakes, out-of-state political groups funneled large amounts of money into the race.

Election-reform advocates hailed McCaffery's election as an important defense against potential gerrymandering and limitations of voters' rights in the state. To understand why, we need to review some of the history of gerrymandering in Pennsylvania, a state that is split nearly 50-50 between Republicans and Democrats. We also discuss steps the PA Supreme Court has taken to counter gerrymandering and other legislative acts that might limit voter's rights.

It is essential for classmates who reside in Pennsylvania to remain vigilant and follow developments in the run-up to the 2024 election. There are still many politicians who, if left unchecked, would seek to enact legislation limiting voting access. Multi-Class Update



Jonathan Sprague and Stan Mark have been working to engage other Harvard classes to join the ClassACT Movement. 
